## WHO CAN BECOME A MEMBER?

Article 7 of the Rosa Lëtzebuerg bylaws mentions both physical and legal entities that can attain membership status. This is done in accordance with the rules of procedure by filling out a membership application. Furthermore, Article 7c states that a non-profit legal entity must have a mission similar to that of Rosa Lëtzebuerg.

Rosa Lëtzebuerg understands comparable or similar missions to be organizations that either engage in LGBTIQ+ rights, promote queer art and culture, or offer protection or a safe space to queer individuals. The organization should also be recognizably a queer association in its work or offerings.

The Board of Directors reserves the right to reject membership applications if it is evident that organizations or individuals pursue motivations contrary to those goals defined by Rosa Lëtzebuerg in our bylaws.

Active members are members who have paid their membership fees for the current calendar year. The membership fee for organizations, as decided at the last General Assembly, is 50€ per year.
